

Medical help off shore

 Sea is basically an isolated environment with limited options for medical care

The quality of medical help on board still depends on:

- the medical training of the person providing medical help
- quality of the medical manual used
- quality of the medical chest on board
- quality of radio medico advice from shore (TMAS).
